THE SERVICES OF VOLUNTEERS ARE AN INDISPENSABLE PART OF THE ORGANIZATION'S PROGRAM ACTIVITIES. VARIOUS INDIVIDUALS CONTRIBUTED THEIR TIME WHICH RESULTED IN 7,279 VOLUNTEER HOURS WITH AN ESTIMATED FAIR VALUE OF \$383,000 FOR THE YEAR ENDED DECEMBER 31, 2015. DONOR CONTRIBUTIONS USED FOR PROGRAM-RELATED ACTIVITIES
DANA DORNSIFE IS FOUNDER AND PRESIDENT OF LAZAREX. SHE AND HER HUSBAND DAVID CONTRIBUTED \$881,651 TO LAZAREX DURING THE YEAR ENDED DECEMBER 31, 2015, WHICH COVERED MORE THAN 100% OF ALL GENERAL & ADMINISTRATIVE AND FUNDRAISING EXPENSES. ACCORDINGLY, ALL DONOR CONTRIBUTIONS RECEIVED FROM OTHER SOURCES WERE USED EXCLUSIVELY FOR PROGRAM-RELATED EXPENSES.
